- ✓ The Research Ethical Committee (REC) convenes faculty and researchers within the research community to deliberate on campus research ethics policies.
- ✓ The REC, a component of the Research Advisory Committee (RAC), evaluates the research activities of both faculty and students at VICAS.
- ✓ In all research endeavors undertaken by staff and students, the REC diligently oversees and upholds high standards of ethics, honesty, and professionalism. Lab notebooks are maintained with dated records, ensuring scrutiny during the publication process or patent filing.
- ✓ The REC diligently tracks all study participants and recommends their inclusion as authors when the research is published.
- ✓ The committee promotes awareness and precautionary measures among academics and students involved in research initiatives, providing comprehensive lab safety training to all VICAS personnel.
- ✓ Serving as a platform for researchers, the committee facilitates discussions on research ethics challenges and their practical implementation.
- ✓ Adhering to the norms of Periyar University and UGC, the committee addresses issues related to plagiarism and malpractice in research operations.
- ✓ The REC authorizes the submission of a scholar's (M. Phil / Ph.D) Dissertation/Thesis only after a plagiarism check by Periyar University, Salem.

INVESTIGATION PROCEDURES FOR RESEARCH MISCONDUCT:

Filing a Complaint:

Individuals are encouraged to submit complaints related to academic misconduct directly to the Principal. This process is independent of a researcher's right to discuss and assess allegations of plagiarism during the routine evaluation of scholarly papers. Complaints should be supported by substantial evidence.

Evaluation by the Principal:

The Principal will assess the submitted complaint to determine its severity and whether it necessitates an investigation by the research committee.

Research Committee Investigation:

If the Principal deems the complaint to be sufficiently serious, a research committee investigation will be initiated. The committee will examine the allegations of research misconduct thoroughly.

These procedures aim to ensure a fair and objective process for addressing complaints related to research misconduct while upholding the researcher's right to engage in discussions and assessments of academic work.
