Vivekanandha College's dedication to OBE reflects its commitment to delivering high-quality education tailored to industry needs while fostering personal development and societal contributions. 20.Distance education/online education:

With exclusive access to platforms like Zoom and G Suite, the institution conducts online classes, webinars, and conferences to facilitate remote learning. Moreover, the institution has an exclusive Learning Management System containing a vast collection of e-books and video lectures, enriching the online learning experience. The College is located in Namakkal District which is renowned for its egg production, Poultry farming, Sugar mills, Paper mills, Tex Valley, Handlooms, Jaggery,

and related products. To cater to these local needs, Courses are offered in Nutrition & Dietetics, Textile and Fashion Design, Costume Design and Fashion, Commerce, Business Administration, and Computer Science Programmes.

Situated in the western region of Tamil Nadu, where there's a concentration of industries in textiles, agricultural products, leather, paper, ICT, pharmaceuticals, and food products, the College integrates relevant courses into its curriculum to meet industry demands of the region. 4.3 - IT Infrastructure

The institution has an approved IT policy, prominently displayed on the Institutional website, which includes specific guidelines for the use of computational facilities. To ensure cyber security, firewalls are provided, and cyber security norms are strictly adhered to. Given its status as a women's institution, special attention is paid to preventing misuse of computational facilities.

To regulate access, user names and passwords are created for all users, with Wi-Fi facilities available throughout the campus. Internet connectivity is provided with a bandwidth of 100 Mbps, and intranet connectivity is extended to all campus buildings via a 32 KBps fiber optical cable.

For network security, the campus employs antivirus software 'K7' along with IP NAT, DMZ, port blocking, and content filtering features. Additionally, Hot-Spot (TACITINE) software is installed to manage user registration, IP assignment, login, time limits, and bandwidth allocation.

To bolster security measures, the entire institute is under 24-hour surveillance, facilitated by 84 CCTV cameras, ensuring the safety and security of the campus environment. These comprehensive measures reflect the institution's commitment to providing a secure and conducive IT environment for its users.

Empowerment through skill development: The Practice: The departments on the basis of the feedback obtained from the stakeholders and based on opinion obtained from the experts, decide on the nature of the skill development courses to be offered. With the approval of the management, the course content is decided by the faculty members of the development and approved by BOS. Free Transportation unit with GPS Tracking facility to ensure safety:

The Practice: The provision of free transport to all students is one of the institution's practices to help the college attain its motto. Connectivity, the primary issue in rural areas, discourages women students and their parents from thinking twice before admitting into the institutions. Worried over the safety of the girl students, parents dissuade their wards not to opt for higher studies. The management has mightily addressed these twin issues by operating 70 buses to remote locations of rural areas not only in the Namakkal District and in neighboring districts at free of cost. The hostellers are also utilize the facility to reach their homes during vacations/festival holidays, reducing the anxiety of theparents. Similar arrangements help the students to return to their hostels after holidays/vacations.

TRANSFORMATION OF RURAL WOMEN STUDENTS

Since its establishment in 1995, the institution has flourished into a prominent group comprising 27 institutions, all dedicated to the empowerment of rural women through education. Recognized for its excellence in teaching, research, and extension activities, the college attained autonomous status in 2010. Currently, it offers 29 undergraduate programs, 17 postgraduate programs, and a Ph.D. program in 11 disciplines.

Many women enrolled at Vivekanandha College are first-generation literates, hailing from economically disadvantaged backgrounds and earning livelihoods through laborious work. To support these students, the institution provides various in-house and government scholarships. Before admission, students undergo a knowledge test called 'Vivekanandha Merit Scholarship Test' and meritorious students receive scholarships throughout their tenure at Vivekanandha College.

Addressing transportation challenges and ensuring student safety, the institution has implemented a free transportation system, a distinctive feature. A fleet of 70 heavy vehicles is deployed to transport students, ensuring pick-up and drop-off even at their doorsteps across seven districts. This initiative instills confidence in parents regarding the safety and accessibility of higher education for their daughters at Vivekanandha College.

Through these measures, the institution continues to transform the lives of rural women students, providing them with opportunities for education and empowerment.
